

### Good Work done of Nadia District Police

1. The fact of the case in brief is that one Puja Das D/o Sudam Das inmate of Nagendranagar Dist. Shelter Home lodged a complaint on 16.10.2015 before Ld. Judges [in-charge of Ld. CJM], Nadia during his visit and duly forwarded vide No. 1385/C dtd. 16.10.15 to the effect that Puja Das is staying at District Shelter Home since 2012 and she was several times raped on different occasions by one Ranjan Kr. Modak, a worker of the Home at the Home itself under threat. Over this incident Kotwali PS Case No. 701/15 dtd. 16.10.15 u/s 376/376[2][d] IPC & Adding Sec-4, Sec-6 & Sec-8 of POCSO Act was started. The case was then endorsed to SI Nilratan Ghosh and during investigation he immediately on 19.10.2015 arrested the sole accused Ranjan Kr. Modak S/o Lt. Panchugopal Modak of Ghurni Pramanick para, Ps-Kotwali, Nadia and forwarded before Ld. Court on 20.10.2015 and after completion of investigation with utmost sincerity he submitted Charge Sheet observing all the formalities. It is praise worthy that he investigated the case so quickly and collected material evidences which will obviously yield conviction of the accused rapist soon.

On 15.03.2015 evening an incident of dacoity took place at Badkulla Bazar under PS Taherpur and Jalalkhali Bazar under PS Kotwali, Nadia and immediately on getting information of retreat of the miscreants with TATA Sumo through Kotwali Ps area, a team consisting SI Nilratan Ghosh, ASI Dipak Kr. Malakar and others chased them taking life risk. Finally with in a few days these team members under the leadership of IC Kotwali PS could identify the vehicle and arrested the accused persons resulting detection of the case and some other gangs could be nabbed who were operating in the area. This refers to Taherpur PS Case No. 39/15 dtd. 15.03.2015 u/s 395/397 IPC
3. On 15.09.2015 night an incident of house theft at Ghurni was reported to this PS which refers to Kotwali PS Case No. 625/15 dtd. 15.09.2015 u/s 379 IPC followed by which the I.O ASI Joy Das very effectively arrested the accused persons, brought them to PS on Police Remand and could recover the particular stolen Motor Cycle. This was a joint successful efforts of SI Nilratan Ghosh which make it possible to nab the total gang members and return stolen motorcycle to the victim party.
4. On 25.08.2015 an incident of house theft at Police Parade Ground Quarter was reported to this PS which refers to Kotwali PS Case No.564/15 dtd. 25.08.2015 u/s 379 IPC followed by which the I.O ASI Joy Das very effectively arrested the accused persons from other PSs area, brought them to PS on Police Remand and could recover the particular stolen Laptop. This was a joint successful efforts of SI Nilratan Ghosh which make it possible to nab the total gang members and return the stolen Laptop to the victim party.
5. Fact of the case is that on 15/10/15 one Sukumar Ghosh S/o Lt Surendra Nath Ghosh of Bhaluka PS Kotwali, Nadia lodged a written complaint to the effect of theft of LCD, cash rupees, golden ornaments etc from his house in his absence. Over this incident Kotwali PS case number 700/15 dated 15.10.2015 u/s 379 IPC has been started and as per endorsement, ASI Kartick Ghosh investigated the case..

During investigation he arrested accused persons and recovered the stolen LCD and gold ornament (98Gram/ almost all) etc. The recovered LCD and gold ornaments were returned to the victim. The victim expressed his utmost satisfaction in the role of Police, specially on ASI Kartick Ghosh..

6. On 15.08.2015 an incident of house theft at Assannagar Bazar was reported to this PS which refers to Kotwali PS Case No. 543/15 dtd. 19.08.2015 u/s 467/379 IPC followed by which the I.O SI Uttam Sarkar very effectively arrested the accused persons from other PSs area, brought them to PS on Police Remand and could recover a good portion of stolen articles including the mobile phones. This was a joint successful efforts of SI Nilratan Ghosh, ASI Dipak Malakar which make it possible to nab the total gang members and recovery of stolen articles.

On 06.08.2015 an incident of house theft at Chodhurypara, Krishnagar was reported to this PS which refers to Kotwali PS Case No. 509/15 dtd. 07.08.2015 u/s 379 IPC followed by which the I.O ASI Uttam Ghosh very effectively arrested the accused persons from other PSs area, brought them to PS on Police Remand and could recover the particular stolen Laptop and mobile phone. This was a joint successful efforts of SI Nilratan Ghosh, ASI Joy Das which make it possible to nab the total gang members and return the stolen materials to the victim party.

On 15.09.2015 an incident of robbery at Ghurni are was reported to this PS which refers to Kotwali PS Case No. 620/15 dtd. 15.09.2015 u/s 392 IPC followed by which the I.O SI Nadim Akhtar very effectively arrested the accused persons, brought them to PS on Police Remand and could recover the stolen articles. This was a joint successful efforts of SI Shib Sankar Bose, SI Nilratan Ghosh, ASI Dipak Malakar which make it possible to nab the total gang members.

In a significant development followed by an effective raid in the month of September'2015, Kotwali PS apprehended some dreaded criminals who committed a murder in the year of 2013 to an innocent people and left him under the other PS jurisdiction. The case was undetected at the concerned PS but at the initiative of Kotwali PS all the accused persons were arrested jointly with Nakashipara PS and the case was reopened which finally ended in Charge Sheet. It is the sincere endeavour of the Kotwali PS personnel that yielded unearh the truth. This refers to Nakashipara PS Case No. 681/13 dtd. 19.08.2013 u/s 302/201 IPC.
10. ASI Dipak Kr. Malakar of Kotwali PS did praise worthy work while he was entrusted with the task of execution of Warrants of Arrest. During this time frame, apart from other regular PS work like arresting notorious criminals, he executed a good number warrants all together 935 in Black ink out of 1055 on receipt and 113 in Red ink.
