

Good Work Done by Uttar Dinajpur District Police

Innovative Practices of Uttar Dinajpur District Police

1. Clean Police Station Competition:

A Clean Police Station Competition is being organized from the last year with the objective of providing a clean and healthy working environment to the officers and force and also for building a better image in the eyes of the citizens. The detailed criteria on which the PSs were evaluated is attached as Appendix A. This has resulted in significantly disposing of old files, papers, vehicles, and proper sorting of the existing files etc. It has also resulted in better facilities for the visiting public at the PS.

2. Wireless CCTV Coverage of Raiganj town area with Community Support:

CCTV coverage is an important tool for prevention and detection of crime as also managing law and order situations effectively. It also builds a sense of security amongst the citizens. The district police held a number of meetings with the local people, political leaders, business community and other stake-holders and elicited their support for installation of high-quality CCTV cameras at various important points of Raiganj town and NH-34. Accordingly, 20 points have been earmarked, out of which high quality wireless cameras have been installed at 7 important points. The installation is expected to be completed by June end. These cameras have already helped the local police in detecting recent cases of dacoity, arrest of the entire gang and recovery of the looted property. The footage of the cameras are being monitored LIVE at a Control Room set-up at Raiganj PS.

3. Women and Child Help Desk:

To welcome and assist the women and children coming to the Police Station, the “Women and Child Help Desk” has been set up in each and every Police Station, which is being manned by Lady Officers/ Constables and Lady CPVF’s. The said desk functions from 09.00 hrs to 20.00 hrs every day in two shifts. Apart from attending to their complaints they are also entrusted with the responsibility of providing feedback to the aggrieved.

Recently the **Raiganj Women Police Station** has started functioning, which investigates important cases of crime against women in Raiganj Sub-Division.

4. Online system for monitoring CD Production in Court:

Using the features of Google sheets, this online sharable database keeps track of the date of CD production in the various Courts of the district from respective Police Stations of the Uttar Dinajpur District. It also minimizes the need for physical delivery of correspondence through *Message/Dak/Order-sheet* to the PS. It helps in tracking the present location of the CDs and also in proper co-ordination between the police courts and police stations regarding CD production matters. It also keeps in check the possibility of CDs lying pending unnecessarily with the bench clerks.

5. State-of-the-art Multi-Gymnasium at Karnajora Police Lines:

A modern Gym for the use of the police personnel and their family members has been built by repairing existing and buying gym equipments. A low subscription of Rs 30 per month is also being collected from the members for proper upkeep, maintenance and purchase of new equipments.

6. Development of Lady RAF Component

In order to better tackle law and order situations involving women, such as in colleges, schools, election campaigns, law violation programme etc and also to better utilize the available strength of LCs, two section of LCs have been trained to act as RAF. At times they are used in combination with male RAF counterparts. LCs with good physique and inclination for performing such duties were selected and rigourously trained in riot-control drill, arms handling, UAC etc. It has also helped to solve the scarcity of special forces at the headquarters.

Ensuring Prompt PO visit within 24 hours:

Visit of the IO to the PO as soon as possible is very important for proper collection of evidence and better and prompt investigation. It also increases the complainant's faith on police and held in faster detection of cases. All officers have been directed to visit the PO within 24 hours of lodging of the complaint. Further, along with their name and address, PSs also mention the Contact No of the complainant for each FIR in the daily sitrep. At the district level, after 2 days of logging FIR, a few complainants at random are enquired about the IO's visit to the PO. The erring IOs are dealt in OR-1 and the concerned OC/IC is directed to visit the PO the same day and report compliance. This has improved police response to the complaints lodged and has also helped in faster investigation and disposal of cases. It also gives a feedback about the functioning of the field units and reduces the need for complainant visiting SP/other senior officers.

7. Upgraded 100 Dial Facility:

Earlier, the 100 dial facility was dysfunctional. Currently it has been upgraded to 2 lines. Contact was made with all Telecom Service Providers for proper configuration at their end. All calls made to 100 dial are routed to the District Control Room, from where the respective PS is informed and a log is kept. The personnel manning 100 dial 24x7 have been sensitized and trained. It has resulted in police getting important information in time besides being helpful for the common people.

Community Policing Initiatives:

Uttar Dinajpur District Police is continuously involved in such community policing initiatives which have a bearing on police work/functioning. These activities include traffic rules, human trafficking, drug abuse and cyber/financial crimes awareness amongst school children, anti witch-killing campaigns in tribal populated areas, awareness against child marriage and human organs racket in affected areas. The district police is also actively promoting sports activities in all PS areas for better police-public relationship. These sports include football, volleyball, cricket, archery etc. Keeping in mind the scarcity of blood in Raiganj Blood Banks, the district police also regularly organizes blood donation camps and free health check-up camps for the under-privileged.

A fortnightly community policing schedule is made centrally for each police unit and distributed to them. Support such as training materials, instructors etc are provided from the headquarters.

Effective Communication using WhatsApp in day to day Policing:

All OCs/ICs/CIs/DySsP/SDPOs/Addl. S.P/S.P are using WhatsApp, through which entire district police administration remains connected continuously. All senior district police officials are in one group, where they share photos, text relating to law and order situation, VIP movements, crime and criminals information, exchange of email etc. It has also resulted in the detection of some cases by sharing of information of other PS officers. Also we create one WhatsApp number (8373050540) through which public can launch their complaint.
