CULTURAL PROGRAMME :

- 248) On the eve of Durga Puja recitation, dance, Rabindra Sangeet etc. programme was organized.
- 249) On the eve of Kali Puja recitation, dance, Rabindra Sangeet etc. programme was organized.
- 250) Paschim Medinipur and Jhargram Police in active co-ordination with district administration undertook pioneering work to facilitate rejuvenation of dying Folk-culture of Bengal. Prior to this initiative, the needy Folk artists were identified and paid a token amount every month to preserve their art and to boost their morale. Besides this, they are being substantially paid for participating in Folk programmes at different places. In line with this idea, Paschim Medinipur and Jhargram Police organized 'Lok Sanskriti Anusthan, 2015' in 30 places of 28 PSs.

In the programme different forms of indigenous Folk culture were highlighted. Some of these forms are Jhumur, Chhow, Paataa Nach, Ranpaa Nach, Baul, Tribal Dance, Kabi Gaan etc.

The programme was a huge success. In some of the venues, more than 7000 audiences gathered to participate. Police - Public relationship reached a new horizon.

251) A cultural programme was organized on 07th December, 2015 by the Home Guards, Paschim Medinipur.

NEW INITIATIVES UNDERTAKEN

252) **Rehabilitation of Ex-Maoists :**

In the first of its kind of package for rehabilitation of Maoists, Hon'ble Chief Minister kindly approved the proposal initiated and pursued by Jhargram Police wherein the bailed out Maoists were considered for Surrender-cum-Rehabilitation Package. This is unique not only for West Bengal but for the whole of India. 49 Maoists from Jhargram and 01 from Paschim Medinipur were finally included in the package and similar proposals from Bankura and Purulia Districts were also considered due to this initiative.

This package was envisaged to ensure that the persons who are now under active surveillance and liaison with the police do not go back to the erstwhile deviant ways and integrate fully with the mainstream of the society. With means of gainful employment and allowances in the police department, these surrenderees' vital role in maintaining peace in Junglemahal has been recognized and rewarded.

As a result of initiatives taken by Paschim Medinipur and Jhargram Police District under direct supervision of Superintendent of Police, Paschim Medinipur and holding additional charge of Jhargram Police District 49 Ex-Maoists of Jhargram PD and 01 ex-Maoist of Paschim Medinipur were re-habilitated against the Surrender Package on 25.11.2015. This initiative has proven to be a water shed in frustrating the Maoists attempt to regroup. Its popularity can be gauged from the fact that many active Maoists are trying to contact police administration for being considered under this package.

253) **Initiatives taken during the Festive Season :**

i) This year the festive season was a unique challenge for policing as Durga Pujo and Muharram were to be celebrated very close in time and space. As both Paschim and Jhargram have quite a few communally sensitive mixed pockets with history of communal incidents in the recent past, preventive steps were the prime focus. Peace committees were formed ahead in time. OCs, Zonal Dy SPs, Addl SP and the SP all

conducted various liaison meetings with members of both communities. All the routes of Muharram Procession were explicitly spelt out and mock exercise by police officers undertaken. These initiatives paid off in the form of communal incident free festive season. It is a milestone for the district as few years ago festive season without communal skirmishes could not be imagined.

- ii) Another initiative during this season which received wide approval and popularity was distribution of identity cards to kids who come out along with their families or otherwise to see and enjoy the Puja. These cards were distributed through Public Assistance Booth manned by Police Personnel at various important junction in every PS area. This added to the sense of security to the families that were out to participate in the Puja and drastically reduced the incidents of missing children. This people friendly initiative received wide spread commendation.
- iii) As a part of strong policing initiative anti eve-teasing and anti snatching teams were formed area wise under the supervision of Dy SP rank officer. Trend analysis of such incident during previous year and real time intelligence collection formed the core of the focus area for the teams. These teams were strongly backed up by zero tolerance NAKA system effectively placed on ground. Young dare-devil bikers and drunken drivers were prosecuted and kept in complete check. Almost no incident of snatching or eve-teasing was reported during this festive season.

254) **INITIATIVE IN TRAFFICE ARRANGEMENTS :**

- i) Going by the adage, “in the eyes of the children, lies the future of our civilization”, Paschim Medinipur and Jhargram Police Traffic Units focused on educating children as a part of the initiative to increase traffic awareness. Traffic personnel during various times of the year visited schools and interacted with the students for making them aware of the traffic rules and safety measures and imparted learner friendly guidelines on the issue. All traffic programmes invariably ensured large participation by the children. Catchy slogans and attractive displays punctuate the entire district in an effort to reach out to the people on the issue of traffic awareness.
- ii) Civic Volunteers were identified on the basis of aptitude and imparted training using the available resources so as to make them an effective part of the traffic man power. The existing traffic personnel were also given refresher courses so as to hone their skills and attitude to the challenging task they undertake. This initiative has effectively addressed the perennial problem on man power shortage in traffic units.

- iii) Another initiative that was undertaken was to institute mechanism for monthly review of dark spots and vulnerable areas and to immediately address the burning issues by improving traffic infrastructure and posting traffic personnel to the identified areas. This initiative has yielded prolific results in terms of reduction of fatal accidents.

- iv) An oft overlooked aspect of traffic management is the feedback mechanism from the civil society. This aspect was sought to be addressed via liaisoning meeting between traffic units and civil society on various aspects of traffic management including declaration of one way (especially during the festive season) and allied issues. This feedback mechanism has become a part of Paschim Medinipur and Jhargram Police traffic management initiative.

255) **Initiative taken to curb down Crime Against Women :**

Various initiative taken to curb down crime against women some of these are follows :

- I) Gender sensitization programme has been organized to sensitize all police officers and member of force as to how to deal with crime against women, how to behave with women complainant or victim girl on the lines of extant guidelines.

- II) In collaboration with local NGOs, Anti-witchcraft programmes were organized in sensitive and vulnerable areas .

- III) Refusal of registering cases relating to crime against women have been looked with zero tolerance, as a result registering of cases at different PSs chiefly to town PSs namely Kotwali and Kharagpur (T) have notably increased.

- IV) All types of crime against women cases have been treated as SR cases.

256) **Initiative taken in Town area to curb down crimes :**

Careful analysis has revealed high incidence of crime against property and organized crime in the cosmopolitan town area. To address this challenge out of the box thinking and initiatives were implemented.

These include :-

- i) Introduction of intensive cycle patrolling.

- ii) Identification of vulnerable areas followed by introduction of special patrolling there.
- iii) Use of well briefed and judiciously selected Civic Volunteers for night guard.
- iv) Introduction of supervision of Dy.SP rank officer on every night.
- v) Introduction of strong NAKA at all the entry and exit points of town area.
- vi) Police has ensured installation of CCTV cameras at all vital commercial institutions and markets.

As a result of the above initiatives crime in general and crime against property in particular has conspicuously come down.

257) **Preventive steps taken for Protection of Minority Institutions :**

In the light of unfortunate Ranaghat incident and the surcharged communal atmosphere noticed time and again, a pro-active system was put into places for protection of minority institutions like churches, mosques, gurudwaras, missionary schools etc. A well briefed contingent of Civic Volunteers was posted at all such institutions. Senior officers of police including Superintendent of Police personally interacted and exchanged numbers with the heads of these institutions. This not only resulted in preventing any mischief mongering incident but also strengthened the sense of safety and security across the cross section of the society.

258) **Special Drive against Fire-crackers :**

- i) In the preceding months since May, 2015 special drive against illegal fire-crackers was launched wherein thousands of KGs of fire-crackers and materials used in making fire-crackers were seized and scores of cases were registered and arrest made in c/w these cases. During the month of May, 2015 total 31 cases were recorded and 15000 of KGs fire-crackers were seized.
- ii) The Pollution Control Board guidelines and High Court verdict on noise pollution were implemented in to during the festive season and Diwali celebrations. These initiatives came as a big relief to the common people aggrieved by indiscriminate use of fire crackers.

259) **Initiative taken to “crack” salboni lead factory dacoity case :**

On 04.09.15 some unknown miscreants entered the lead factory of one Madhusudan Agarwal at Asmanchak, PS – Salboni and looted away 3300 kgs of lead from the said factory and one mobile set from one staff. This refers to Salboni PS Case No. 160/15 dated 04.09.15 u/s 395/397 IPC and 25/27 Arms Act. Superintendent of Police, Paschim Medinipur directly supervised the case and using CDR analysis and tower dump noted criminal Guruprasad Das Adhikary and his associates were identified and arrested. It later came to light that the same gang had looted mustard oil and mobile phones from Jay Bhabani Oil Mill under Kotwali PS and was also the perpetrator of dacoity of 13 drums of oil from a patrol pump under Kharagpur (L) PS. The gang was planning to commit dacoity at Chandrakona town when the police apprehended them. This way three cases were cracked and another dacoity prevented.

260) **Trial Monitoring :**

Proactive measures were undertaken to implement the order on trial monitoring both in letter and in spirit. Regular meeting of the Trial Monitoring Cell and the IOs of the important cases that have been charge-sheeted was ensured. As a result of this initiative the conviction rate has drastically improved in this year.

261) **Operation Muskan :**

During the month of July, 2015 Operation Muskan was conducted throughout Paschim Medinipur and Jhargram. In that the officers of the rank of Inspector directly participated in the programme and total 39 events were conducted. This operation was conducted with help of Block Level Child Protection Committee. Awareness programmes were conducted, leaflets on the relevant subject were distributed and the views on different aspects of child protection were exchanged. During this operation, total 20 children were recovered and rehabilitated. This programme was a huge success.

262) **Lok-Sanskriti Anusthan, 2015 :**

- i) Paschim Medinipur and Jhargram Police in active co-ordination with district administration undertook pioneering work to facilitate rejuvenation of dying Folk-culture of Bengal. Prior to this initiative, the needy Folk artists were identified and paid a token amount every month to preserve their art and to boost their morale. Besides this, they are being substantially paid for participating in Folk programmes at different places. In line with this idea, Paschim Medinipur and Jhargram Police organized 'Lok Sanskriti Anusthan, 2015' in 30 places of 28 PSs.

263) **Initiative taken during Summer :**

During the summer months of June-July, 2015 the following initiatives were taken to cope with the scorching weather and its fall out :-

- i) The duty hours of Traffic Police personnel was changed from 4 hours to 2 hours.
- ii) Shifting pattern of duty was implemented.
- iii) 'Jalachhatra' initiative was taken in each PS area particularly near Bus Stops, Railway Stations and other frequented places where there was no facility of drinking water in the difficult weather conditions.
- iv) Glucose / ORS packets were distributed to commuters to protect against sun-stroke.

All these efforts were duly praised by common people.

264) **Rehabilitation of Flood Affected People :**

During the last rainy season a large part of Paschim Medinipur and Jhargram Police district got affected. These places include Gopiballavpur, Nayagram, Keshiary, Sankrail, Beliabera, Keshpur, Ghatal, Daspur and Kotwali PSs. Police personnel took following steps to mitigate the disaster caused by flood:-

- i) Alerting the people of flood prone areas before hand and helping them to move to secured places.
- ii) Distribution of tarpaulins, blankets, dry foods, water etc. by police personnel to far flung areas.
- iii) Ensure evacuation process is fast and smooth in liaison with other agencies.
- iv) Officers of the rank of DySP and superiors to them personally participated in such operation and ensured all sorts of assistance reached the affected people in time.

265) **Training of Civic Volunteers :**

With a view to upgrade performance of Civic Volunteers to the level of HG/NVF various initiatives were taken some of these are as follows :

- i) The Civic Volunteers have been properly trained to assist police in law and order situation, visits of VVIPs and Traffic management.
- ii) A different type of force namely 'Rope Force' has been formed out of the Civic Volunteers. They have been issued a rope for every two Civic Volunteers. They have been so trained that they immediately and quickly forms a line to keep the crowd away from obstructing the route of VIP or from any place of occurrence of law & order incident.

266) **Improved Police Public Interaction through Programmes and Celebrations:**

A systemic initiative that has been made a part of police public interaction is ensuring the full police participation in public programmes/functions like inauguration of pujas, participation in Iftar parties, attending cultural and sports meet etc. and extending the concept further by making respectable people, differently abled persons, meritorious students and needy individuals a part of all police programmes like Annual Sports, Bara Khana, Debate Competition etc. The needs and merit of civil society is duly recognized through felicitation during such programmes. This interface has created an amiable atmosphere which has helped in curbing communal and law & order problems and has distinctly strengthened the informal channel of communication needed by the police to meet the modern day challenges.

267) **PREVENTIVE STEPS TAKEN FOR PROTECTION OF MINORITY INSTITUTIONS**

In the light of unfortunate Ranaghat incident and the surcharged communal atmosphere noticed time and again, a pro-active system was put into places for protection of minority institutions like churches, mosques, gurudwaras, missionary schools etc. A well briefed contingent of Civic Volunteers was posted at all such institutions. Senior officers of police including Superintendent of Police personally interacted and exchanged numbers with the heads of these institutions. This not only resulted in preventing any mischief mongering incident but also strengthened the sense of safety and security across the cross section of the society.
