

## **West Bengal Societies Registration Act**

### **Memorandum of Association**

1. The name of the Society will be Indian Police Service Officers Welfare Society, West Bengal.
  
2. The Registered office of the Society shall be situated at Indian Police Service Mess, 11, National Library Avenue, Alipore, Kolkata-700027.
  
3. Object of the Society:
  - i. To undertake social welfare schemes at NO PROFIT NO LOSS basis for the officers of Indian Police Service, West Bengal Cadre, by inter alia construction of houses for officers and spouses of such officers who die while in service and providing all possible help and required inputs to achieve this object.
  
  - ii. To achieve a quality of life which will promote a genuine sense of integration, harmony and goodwill amongst the officers of Indian Police Service, belonging to West Bengal Cadre, so as to enhance their output in public interest.
  
  - iii. To maintain library, community centre, sports facility and undertake other welfare activities for the officers of Indian Police Service, belonging to West Bengal Cadre, and their families.
  
  - iv. To do all such things as are incidental or conducive to attainment of the above objects.

The functions and objects of the society shall always remain restricted within the meaning of the section 4(2) of the West Bengal Society Registration Act 1961 irrespective of any object mentioned in the present document in agreement or opposed to said section.

Before commencing the activities of the society, necessary approval/permission will be obtained from the Govt. or other appropriate/concerned authorities as and when required.

The income and properties of the society wherever derived or obtained shall be applied solely towards the promotion of the object of the society and no portion thereof shall be paid to or divided amongst any of its members by way of profits/dividend/bonus/incentive/any financial advantage whatsoever.
