

TENDR NOTICE

Sealed Tenders are invited from bonafide firms / concern for offering their rates towards supply of Motor Spare Parts, Repairing Works, New Tyre & Tubes and Batteries of Govt. vehicles / Motor Cycles of Purba Medinipur District Police for the financial year 2017-2018. The list of motor Spare-parts and Repairing works' items containing terms & conditions will be had from Motor Transport Section, Tamluk Police Lines, Purba Medinipur on all working days during office hours within 20 (Twenty) days from the date of publication of this tender notice on production of Treasury Challan amounting Rs. 200/- (Rupees Two hundred) to be drawn from State Bank of India, Railway Station Branch, Nimtola, Tamluk in favour of the undersigned, valid license, GST registration certificate with number, Voter ID card, PAN card, Addhar card, Bank account details and security deposit of Rs. 10,000/- (Rupees Ten thousand only) each for supplying motor spare parts and Repairing works in the form of NSC / KVP. Sealed Tender is to be superscribed as 'Tender for Supplying Motor Spare Parts' / 'Tender for Repairing works' / New Tyre & Tubes / Batteries (which will be applicable) for Govt. vehicles / Motor Cycles of Purba Medinipur District Police and to be addressed to the undersigned should positively be dropped / submitted in the Tender box to be kept in the office of Addl. Superintendent of Police (HQ), Purba Medinipur within 20 (Twenty) days from date of publication of this tender notice by 12:00 hrs. The rates should be quoted inclusive of all taxes after observing the formalities of GST rules. The Tender Box will be opened on the same day at 14:00 hrs. in presence of Tender participants / their representatives.

TERMS AND CONDITION

1. Tenderer shall have to submit separately photocopies of all relevant documents like dealership certificate / supplier certificate / trade licence / registration / GST registration certificate with number etc. along with tender form in support of his / her / their legal and valid competency as tenderer. Tenderer(s) shall have to submit his / her / their beneficiary details on prescribed form duly signed along with photocopy of the supporting documents (PAN card, Aadhar card, Bank A/C No, Bank A/C type, Branch name with IFS code of the Bank, MICR code, E-mail ID, the mobile no which is linked with his / their bank A/C & Aadharetc.) while submitting the tender.
2. "EARNEST MONEY" Rs. 10,000/- only for Motor Transport (MT) spare parts / job works is to be furnished along with tender in the shape of Deposited at call (Bank Draft only) in favour of the Superintendent of Police, Purba Medinipur. Earnest money of unsuccessful bidders shall be refunded within 30 days from the date of opening of tender.
3. If last date of dropping and opening of Tender is declared as holiday for any reason of office hours is paralyzed due to any unforeseen reason, last date of dropping of opening of tender will be extended up to 16:30 PM of next working day.
4. Rate should be quoted inclusive of all taxes.
5. The tender shall be selected separately for each item on the basis of the lowest rate or other valid consideration as per terms & conditions, experience, supply time etc.
6. The firm should be deposited the bill at MT Section within 25 days from the date of order slip issued, major work may be done within 20 days from date of handover the vehicle. If firm has any court case, fail the GST registration etc. the contract / deal may be cancelled.
7. Failure to supply the items(s) may led the tenderer to be liable for legal action for causing loss to MT Section, Purba Medinipur district.
8. If tenderer fails to do the repair the vehicle or supply the spare parts in time or refused to do repair the vehicle or supply the spare parts as per specification/mark/brand and quality....etc. his earnest money may be forfeited and supply order for the same may be given to the firms / tenderer quoted 2nd/3rd lowest rate or may be procured from the open market after inviting fresh quotation. At the same time for causing loss to MT Section, Purba Medinipur district by not supplying any of the items may invoke penalty like forfeiture of earnest money or even black listing of the firm.
9. Payment will be made after delivery of the materials and on realization of bill from Government Treasury based on availability of fund and sanction from appropriate authority wherever required. Payment will be made through e-payment to bank account during final payment of the bills, that should be reduction as per provision including in HRMS payment.
10. The undersigned reserves the right to reject any of the tender items including the lowest one without assigning any reasons for same at any point of the after publication of Notice Inviting Tender with due consideration.
